SECTION 1

AN OVERVIEW OF EVIVE THE REGENT THEATRE MUDGEE INC.

Our Mission

Our mission is to ensure the public are informed regarding the Regent Theatre in Mudgee's current status after sitting dormant for a number of years. Since 2017 when a development application was lodged for a hotel that would see significant loss to the theatre including demolition of the auditorium we have lobbied via local & online petitions, social media and public events.

The objects of the association are:

- 1. To bring together people who share a vision to revive the Mudgee Regent Theatre closed since 2007.
- 2. To advocate for arts and cultural development in the Central West.
- 3. To advocate for the protection of the Regent Theatre through permanent State Heritage listing.
- 4. To hold fundraising events to promote the goals of the organisation and if possible purchase the theatre.

Our Vision

Our vision is to see Mudgee's closed theatre revived and operational as a multi-purpose theatre. Advocating for The Regent Theatre protection and state heritage listing to ensure it remains intact as an Art Deco theatre. The organisation will work to reinforce the Regent's value as a cultural space.

Our History

Revive The Regent began as a blog and Facebook group in March 2017, founded by Simone Sheridan, to act as a centralised online resource for community and members of the public to learn more about The Regent Theatre in Mudgee. The ultimate aim is to see the theatre actively used as a cultural centre.

In May 2019 we were awarded the Advocacy Award at the NSW National Trust Heritage Awards. At a Public Meeting in April 2019 it was decided to form an incorporated association. We have organised public meetings, rallies and events to discuss how to save the theatre.

In November 2017, a submission made via our blog contact form from a local Mudgee resident, brought to attention a newly proposed development for the site of The Regent Theatre. The development application proposed a 5-storey hotel which would see the demolition of the auditorium. Responding to the community responses, a petition was established and (RTR) actively advocated for the building's protection and for Mid-Western Regional Council to reject the proposed development.

Acting as a voice for the theatre, our group has been able to engage with a range of stakeholders to discover new historical facts including the building's correct designer, George Newtown Kenworthy, which has added to the building's state heritage value. Pooling together finances, our community group raised \$3300.00 dollars to contribute towards commissioning Lucas Stapleton and Johnson Heritage Advisors to submit a well-researched and thorough objection to the DA, which assisted in identifying further state significance of this iconic Art Deco theatre built in 1935.

STRUCTURE & MANAGEMENT

Revive The Regent Theatre Mudgee Inc. is registered with the Australian Charities and Not-for-profits Commission (ACNC).

President Report

It is important to thank the fourteen donors who assisted in funding the objection paperwork that was submitted by LSJ Architects which was crucial in defending The Regent against the hotel development application. At the time (late 2018), we were not a registered charity and we needed to respond quickly to the pending DA deadline, so sincere gratitude to the community members who helped fund the cost of \$3,500.00.

Since our formation as an Incorporated Association in May 2019 there have been a number of changes regarding the property ownership of The Regent Theatre including an auction on 6 March 2020 was cancelled at the eleventh hour. Our organisation had a goal of ensuring the proposed Development Application which entailed demolition of the auditorium to construct a hotel was not successful

Our committee has had a number of changes and I'd like to thank the founding members who helped establish our incorporated association in April 2019.

Newsletters

Our quarterly newsletter has been a key tool in sharing information about our activities and news regarding The Regent Theatre Mudgee. We have produced six newsletters since April 2019.

A number of our volunteers were able to attend the awards ceremony in May 2019 and it was a great milestone to celebrate our advocacy work which has been nationally recognised.

Petitions

We have helped deliver two petitions since 2018; the first (Revive the Regent Theatre Mudgee - STOP DA0081/2018) against the hotel development application which resulted in a confirmed victory with 2916 supporters signing this petition and the second, to encourage Mid-Western Regional Council to purchase the theatre (Mid-Western Regional Council To Purchase Mudgee's Regent Theatre) is still currently open to signatures and is currently signed by 2,700 people.

Fundraising Research

After the public meeting held on 15 February 2020 at The Stables, attended by31 people, it was determined that a fundraising pledge drive be created to determine how much money could be raised by our community, if urgently needed for a deposit at the March 2020 auction. A total of \$20,100.00 was pledged by thirty-three people.


Property Research

As outlined in the newsletters, property research including owner information, company and land title searches have been conducted on a regular basis to ensure our information is up-to-date. Currently, the building is being managed by a liquidator after a federal court hearing resulted in the closure of the company that owned The Regent Theatre. The liquidator has begun cleaning and maintenance required as part of the State Heritage Orders and we anticipate the building going back on the market via auction in the coming future.

Country Arts Support Program Grant Application

Although our first funding application (to present 2020 Forum) was not successful, we now have the work to continue to build on to present a community event that will promote The Regent Theatre. 2020 Forum in Mudgee NSW aims to explore arts, cultural and heritage cultural matters which have arisen since Revive The Regent began in 2017, around cultural planning, state heritage registration and Interim Heritage Orders. We aim to provide an opportunity to increase knowledge and participation from the community.
